

# ORDINANCE NO. 869

## AN ORDINANCE AMENDING CHAPTER 69 OF THE ELDORA MUNICIPAL CODE

BE IT ENACTED by the City Council of the City of Eldora, Iowa:

Section 1. **Purpose.** The purpose of this ordinance change is to amend portions of Chapter 69 Parking Regulations of the Eldora Municipal Code by removing sub section 4 under section 69.03.

**69.03 ANGLE PARKING.** Angle or diagonal parking is permitted only in the following locations:

Subsection 1, 2 & 3 will remain the same. 5, 6 & 7 will be renamed 4, 5 & 6

Section 2. **Purpose.** The purpose of this ordinance change is to amend portions of Chapter 69 Parking Regulations of the Eldora Municipal Code by adding sub section 101 under section 69.08.

**69.08 NO PARKING ZONES.** No one shall stop, stand or park a vehicle in any of the following specifically designated no parking zones except when necessary to avoid conflict with other traffic or in compliance with the direction of a peace officer or traffic control signal.

101. Washington Street, on the east side, from seventy six feet (76) north of Twelfth Avenue to ninety seven feet (97) north of Twelfth Avenue except for loading zone parking;

Section 4. **Purpose.** The purpose of this ordinance change is to amend portions of Chapter 69 Parking Regulations of the Eldora Municipal Code by adding sub section 101 under section 69.08.

Section 5. **Effect.** All other Sections of said Chapters shall remain unchanged and in full force and effect.

Section 6. **Severability.** If any section, subsection, paragraph, subparagraph, sentence, clause or phrase of the Code is, for any reason, held to be invalid or enforceable as to any person or circumstances, the application of such section, subsection, paragraph, subparagraph, sentence, clause or phrase to persons or circumstances other than those as to which it shall be held invalid or unenforceable, shall not be affected thereby, and all other provisions of the Code, in all other respects, shall be and remain valid and enforceable.

Section 7. **Effective Date.** This ordinance and the Eldora City Code shall be in full force and shall take effect, from and after the adoption and publication of this ordinance.
