ORDINANCE NO. 894

ORDINANCE VACATING THE ALLEY RUNNING NORTH AND SOUTH AT THE CORNER OF 15th STREET AND 24th AVENUE IN BLOCK 9 OF THE GREEF ADDITION, CITY OF ELDORA, HARDIN COUNTY, IOWA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ELDORA, HARDIN COUNTY, IOWA.

SECTION 1. Purpose. The purpose of this ordinance is to vacate the alley at the corner of 15th Street and 24th Avenue in Block 9 of the Greef Addition of the City of Eldora, Hardin County, Iowa, pursuant to Iowa Code Section 354.23, as follows:

The complete alley is hereby transferred to the following adjacent property owners:

Midwest Liquid System Commencing at the ---- Corner of Lot 5 as the point of beginning, thence ---- XX feet, thence ---- ---- Feet, thence ---- XX feet, thence ---- XX to the point of beginning.

SECTION 2. Vacation. That all of the north/south running alley (at the corner of 15th Street and 24th Avenue in Block 9 of the Greef Addition of the City of Eldora, Hardin County, Iowa) is vacated.

SECTION 3. Ownership retained. The City hereby retains ownership of and all easements for utility purposes and rights of ingress and egress if currently existing.

SECTION 4. Repealer Clause. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 5. Severability Clause. If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional by a court of competent jurisdiction, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 13. Effective Date. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
