ORDINANCE NO. 896

ORDINANCE VACATING 15th STREET SOUTH OF 24th AVENUE IN BLOCK 9 OF GREEF'S ADDITION,
CITY OF ELDORA, HARDIN COUNTY, IOWA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ELDORA, HARDIN COUNTY, IOWA.

SECTION 1. Purpose. The purpose of this ordinance is to vacate 15th Street South of 24th Avenue in Block 9 of Greef's Addition of the City of Eldora, Hardin County, Iowa, pursuant to Iowa Code Section 354.23, as follows:

The East one-half of said 15th Street to Midwest Liquid Systems, Inc., AND

The West one-half of said 15th Street to Harold A. Meyer.

SECTION 2. Vacation. That all of 15th Street South of 24th Avenue, in Block 9 of the Greef's Addition of the City of Eldora, Hardin County, Iowa is hereby vacated.

SECTION 3. Ownership retained. The City hereby retains ownership of and all easements for utility purposes and rights of ingress and egress if currently existing.

SECTION 4. Repealer Clause. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 5. Severability Clause. If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional by a court of competent jurisdiction, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 6. Effective Date. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
